Park Radio is a community broadcaster, supporting neighbourhood initiatives and public services for people living in the Waveney Valley, including the market towns of Diss, Harleston, Eye and many surrounding rural villages. Our aims are to enhance the wellbeing of local people by providing opportunities to improve social cohesion and the sense of community harmony and pride. The station is a pivotal resource for local communities, providing social interconnections that can rally people together to help find solutions to local concerns and to spark imagination on what we can do better. The station is supported by a diverse network of resident volunteers, local businesses, and community organisations, who benefit from our support and broadcast reach in excess of 80,000 listeners.

10. Briefly describe the project or purchase you would like the funding for and how will it benefit the people of Eye:

Our Proposal is to provide satellite studios in the Towns of Eye and Harleston to enable us to more directly engage local residents and community groups. The aim is to regenerate recovery from Covid-19 and further strengthen all aspects of community unity. It will also be a very green way of allowing more residents to have access and be able to broadcast on the station. We be able to run our youth programmes live from each town. While we are asking for a contribution towards the cost of the Eye Studio, we also need premises and if these can be provided at a notional rent, our overall cost estimate will be reduced.

11. How will the funding benefit the community or residents of Eye?

Our strategic local drop-in studios will enable us to provide training for local volunteers, on the spot on-air interviews for local people to air their views, concerns and ideas and a link to all local businesses and community groups. We will be at the heart of each major centre of the community. Our local studios will facilitate community cohesion, assist in news gathering and reporting, event promotion and a means of attracting tourism and business from people checking out your local radio station on their radios and listening devices.
